HOW TO USE

Dilute 30mls of Reflect to 500mls with water. Spray a light mist onto the surface then polish dry with a paper towel or clean, lint-free cloth.

NOTE: This is a suggested use guide only. Concentration may be varied according to the degree and persistence of soilage.

WHERE IT WORKS

Reflect is a professional-standard cleaner that delivers streak-free results on all shiny surfaces in a single pass. Easily removes all type of soilage including finger marks, oil and greasy films, smoke residues, and more from glass, stainless steel, and chrome surfaces. Reflect is perfect for achieving a clean and sparkling finish on glass and mirrors.

HOW IT WORKS

The surfactants in Reflect are known as colloidal particles that work to dissolve soil at a macromolecular level. These particles decrease the solution's surface tension; and attack, encase, and extract soils from the surface allowing it to be washed away with ease.

Chemrose maintains Safety Data Sheets (SDS) on all of its products. These sheets contain information that you may need to protect your employees and customers against health or safety hazards associated with our product. Chemrose recommends that you obtain a copy of the respective SDS sheet prior to using this product. The information in the Product Data Sheet is based on data we believe to be reliable. HEALTH

Concentrated Reflect is classified as hazardous according to the criteria of Safe Work Australia. It is irritating to the skin and causes serious eye damage. Reflect is a hypo-allergenic*, water-based cleaner that contains no perfumes and no toxic ingredients. With low levels of volatile organic compounds, Reflect will not compromise the indoor air-quality of buildings it has been used to clean.

Reflect becomes non-hazardous when diluted to 1 in 8 (12.5%) in water. Please refer to the safety data sheet for more information.

*Hypo-allergenic means every possible care has been taken in formulation and production to ensure the lowest possibility of allergic reactions occurring in sensitive individuals.

QUALITY

The design, manufacture, and supply of all Chemrose products is controlled by the Quality Management System which is registered and externally audited by SAI Global as complying with the requirements of AS/NZS ISO 9001 "Quality Management Systems – Requirements".

DISPOSAL INFORMATION

1. Used solutions

Used solutions of Reflect should be poured into a drain or trough that leads to the sewer system or a septic tank. These systems have a method for treating and breaking down the waste.

Used solutions of detergent should not be poured into stormwater drains or down driveways as these drains are designed for rain water and ultimately lead to the local river system. Although Reflect has a low aquatic toxicity, detergents in general are not good for aquatic wildlife.

2. Unused product

It is best to keep the product and use it up! If this is not possible, try to give it to someone who can use it. (Make sure the product is in its original, labelled container). If there is no alternative but disposal, it is safe to pour modest quantities of this product down the drain (to sewer) with running water. Leave the cold tap running for a few moments afterwards as this dilutes the product and reduces the concentration in the wastewater. Remember, do not mix different cleaning products together during disposal!

3. Empty packaging

Bottles

Our 5L bottles are made from HDPE (polyethylene) or PET which can be recycled. You can dispose of these containers via the kerbside collection program or other recycling system. Reflect containers will be cleaned and reused if returned to Chemrose Suppliers Pty Ltd., significantly reducing plastic usage and waste.

Cardboard cartons

Our cartons contain a minimum of 70% of recycled cardboard and/or paper. Used boxes should be flattened and recycled in OCC (old corrugated cardboard) or mixed waste paper recycling programs.
