4. FIRST-AID MEASURES

Inhalation

If inhaled, remove affected person from contaminated area. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position. Apply artificial respiration if not breathing. Seek medical attention.

Ingestion

Do not induce vomiting. Wash out mouth thoroughly with water. If vomiting occurs, give further water to achieve effective dilution. Seek immediate medical attention.

Skin

Wash skin with plenty of water. Ensure contaminated clothing is washed before re-use or discard. Seek medical attention if burning, irritation or redness develops.

Eye contact

If in eyes, hold eyelids apart and flush the eyes continuously with running water. Remove contact lenses. Continue flushing until advised to stop by the Poisons Information Centre or a doctor, or for at least 15 minutes. Seek immediate medical attention.

First Aid Facilities

Eyewash, safety shower and normal washroom facilities.

Advice to Doctor

Treat symptomatically.

5. FIRE-FIGHTING MEASURES

Fire Fighting Measures

Keep containers exposed to extreme heat cool with water spray. Fire fighters to wear self contained breathing apparatus if risk of exposure to products of combustion or decomposition.

Use carbon dioxide, water fog or fine water spray. Use media appropriate for the surrounding fire conditions.

6. ACCIDENTAL RELEASE MEASURES

Spills & Disposal

Minor spills do not normally need any special clean up measures. In the event of a large spill, prevent spillage from entering watercourses. Wear appropriate protective equipment (as listed in Section 8 of this SDS) to prevent eye and skin contamination.

Spilt material may result in a slip hazard and should be absorbed into dry, inert material to be collected in appropriately labelled containers for disposal by an approved agent according to local regulations.

Residual deposits will remain slippery, wash down with excess water. If contamination of drains or sewers occurs advise local emergency services.

7. HANDLING AND STORAGE

Precautions for Safe Handling

Avoid contact with incompatible materials. When handling DO NOT eat, drink or smoke. Keep containers closed at all times. Avoid physical damage to containers. Always wash hands with water after handling.

Conditions for safe storage, including any incompatibilities

Store in a cool dry well-ventilated area. Do not store in aluminium or light alloy containers. Keep containers closed when not in use, securely sealed and protected against physical damage. Inspect regularly for deficiencies such as damage or leaks.

Appropriate Engineering Controls

Uses and Restrictions

TOILETS & URINALS. Apply undiluted, product will cling to the surface. Lightly brush or leave to work by itself. Stainless steel areas may require a hand pad to assist build up removal. Flush surface with water. SHOWERS & BATH- Apply undiluted then sponge with a scourer. Rinse off once the shower or bath has been cleaned thoroughly with product. Use on a regular basis as a maintenance cleaner at the rate of 100mls in 1L of water, then flush surfaces with water. BENCHTOPS, WALLS, SINKS & TAPS: Dilute 100mls in 1L of water. Spray areas and wipe with a sponge or cloth. FLOORS: Dilute 10/20mls in 1L of water and mop on tiled floors.

User Information

This is a powerful formulated product for use in washrooms and toilet areas. Removes soap scum, calcium scale and rust stains. Inhibits mould and mildew.
