SECTION 4: First aid measures

4.1. Description of first aid measures

General information

Get medical attention immediately. Show this Safety Data Sheet to the medical personnel.

Inhalation

Remove affected person from source of contamination. Move affected person to fresh air and keep warm and at rest in a position comfortable for breathing. Maintain an open airway. 7.1. Precautions for safe handling

Usage precautions

Read and follow manufacturer's recommendations. Wear protective clothing as described in Section 8 of this safety data sheet. Keep away from food, drink and animal feeding stuffs. Avoid exposing aerosol containers to high temperatures or direct sunlight. The product is flammable. Keep away from heat, hot surfaces, sparks, open flames and other ignition sources. No smoking.
